#### 10. Head Teacher's Report

The Head Teacher provided a comprehensive report to the Local Governing Body, a copy of which is held on file.

The Head Teacher provided an update in her report on Ofsted Priorities setting out the progress/impact achieved towards these priorities. The 8 priorities have been highlighted RAGed to show the progress being made towards a potential good grading. Those highlighted in yellow still required development and embedding, those in dark amber are the areas that least impact has been seen due to the enormity of the task. The key area of focus is Quality of Education and specifically SEND provision and implementation in the classroom to meet the needs of all learners.

It was noted that 'Brain Based' learning had been introduced in early September 2023 and would continue to be rolled out throughout the year. This involved developing understanding regarding how children think and learn and had significant benefits for those with SEND to support access to long term memory and learning. An internal post had been appointed for supporting Quality First Teaching with a literacy focus that will support literacy across the school and support the SEND agenda. The Academy would also continue to support awareness of SEND through the focus five agenda.

The Head Teacher also updated on the Personal Development curriculum implementation; she advised Life lessons and professional development were quality assured during the last term as part of 'deep dives' however, more rigour is needed to assess this more accurately. Careful planning is in place to blend the Life and PSHEC (Personal, Social, Health and Economic Curriculum). It was noted further work was being undertaken to ensure:

- all students are able to explain the essence of British Values and protected characteristics.
- key elements of the PSHEC / Sex Education curriculum are taught effectively.
- Training of staff in this area and the requirement for them to be aware of some of the key issues that are raised within the Life lessons and how to ensure that delivery of topics is experiential and fits the brain based agenda.
- The mapping of external visitors and trips to further enhance the curriculum and the opportunities that it provides for the students and has impact.

The Head Teacher advised that the monitoring visit by Ofsted on the 21<sup>st</sup> September 2023 had been positive. Governors enquired what was the greatest

barrier to achieving further improvement for future Ofsted inspections? The Head Teacher advised the recruitment and retention of staff was of high priority at Longfield, to enable high quality of teaching and learning.

Governors advised the meeting that the Year 6 Open Evening held at Longfield for Year 6 in the Autumn term had been positive and transition information to the schools had been good.

The Head Teacher reported on attendance figures and advised work was continuing to monitor and address support measures and interventions to improve attendance. Governors would continue to monitor attendance of SEND and Pupil Premium Pupils for whom attendance was noted to have dropped.

With regard to child-on-child statistics from September 2023 incidents will now be logged as child-on-child incidents and only once confirmed will be logged as child on child abuse. This would ensure figures are accurate.

The Head Teacher reported upon the Year 11 results for 2022/23, which were noted to be good. Updated Year 11 progress would be brought back to the next meeting of the Governing Board.

Student Voice survey results from June 2023 were noted to be positive. It was noted every term there was a staff well-being forum. In June 2023, the forum focused on creating a new staff wellbeing charter, that has now been put into place. It was noted going forward parental views would be assessed every parents' evenings.

The Chief Financial Officers (CFO), Trust Business Manager and Trust ICT Manager's update reports were noted, a copy of which are contained in the Head Teacher's Report.
