The Governance & Policy Officer provided an update on the Longfield Academy Local Governing Body membership and advised that following a Parent Governor election that Stephen Goodman had been duly elected as a Longfield Parent Governor as of the 8th March 2024. It was also noted that Governor Nicola Bales (Chair) had been duly appointed by Directors as a General Governor as of 11th March 2024.

6. Approval of minutes / review of actions / matters arising

Draft minutes of the Local Governing Body meeting of Longfield Academy held on Monday 29^{9th} January 2024, had been shared with the Governing Body prior to the meeting for their consideration. A copy is held on file.

It was noted there were no matters arising and all actions had been completed.

Governors **RESOLVED** that the minutes of the Local Governing Body meeting held on Monday 29th January 2024 were confirmed as an accurate record of the meeting and should be signed by the Chair.

PART B: Business items for discussion

7. Chair's Report

It was noted that there were no new updates from the Chair.

8. Head Teacher's Report

The Head Teacher provided a comprehensive report to the Local Governing Body, a copy of which is held on file. SEF (Self Evaluation Form) information was included within the Head Teacher's report.

The Head Teacher advised that pupil numbers had increased since the beginning of the Academic Year, with numbers on roll having increased by 10. Attendance was slightly above national average and the Academy continues to focus on serious persistent absentee children.

Governors noted that suspensions were higher at the start of the Academic Year Governors advised that they were pleased that the Head Teacher 's report provided comprehensive data of suspensions on a half termly basis, which they found helped them 'drill down' to further understand and analyse the data. Head Teacher advised when data was analysed suspensions included pupils who had subsequently been permanently excluded and suspensions at the time of reporting had decreased. The permanent exclusion figures were considered by Governors, who noted permanent exclusions were only implemented when all interventions and support strategies had been fully exhausted by the School.

Alternative provision was noted to be limited in Darlington and the Head Teacher shared that the options for alternative provision were not academic. This suited children who require emotional and social support but few provide academic support alongside this. Governors questioned as the Trust increased in size if this is something they could look at providing? The CEO advised this was something that could be explored in the future.

The Head Teacher provided a comprehensive safeguarding update to the Local Governing Body. It was noted that child protection incidents had reduced. During the Autumn Term there had been a series of assemblies around Personal Development British values, Prevent and expectations of behaviour in the Academy.

Year 11 Mocks had been completed with results being monitored and appropriate interventions in place where required. As well as interventions Year 11 are completing how to revise workshops and tutoring to aid in their preparations for exams. Governors noted Pupil Premium and SEND children's progress continued to be monitored with appropriate interventions in place where necessary.

Governors enquired about the progress of the Ofsted priorities? The Head Teacher reported that all 8 key Ofsted priorities had been addressed, some are now embedded and some were in the process of being embedded as set out in her report. The quality assurance process continued to focus on accessibility and Quality First Teaching. Deep dives by senior leadership continued to take place in the academic year. Personal Development continued to be embedded. Assembly themes link directly to the themes explored in form time and in the life curriculum to encourage children to make links to different areas of learning. It was noted parents view continued to be collected at parents' evenings, with the results set out in the Head Teacher's report and considered by the Local Governing Body.

The Chief Financial Officer (CFO), Trust Business Manager and Trust ICT Manager's report were noted by Governors, with no issues of concern identified.

EDP Autumn Visit Report

The Autumn Term Educational Development Partner (EDP) report was considered and noted by the Local Governing Body. The Head Teacher advised that the next EDP visit would be completed on the 19th March 2024 focusing on the development and impact of senior leaders progression with the 8 Priorities.

He advised that Governors at Queen Elizabeth Sixth Form College had completed and approved the due diligence of Swift Academies, approved the Transfer Agreement and dissolution of the College. Work was ongoing for the bringing together of the two institutions including amalgamation of policies, development of the Inicio Academies website, creation of Inicio Academy ID badges and Inicio email addresses. Swift Directors would be considering due diligence of Queen Elizabeth Sixth Form and approval would be sought to the formation of Inicio Academies with relevant appointments/resignations of the new Board/Queen Elizabeth Sixth Form College Local Governing Body at a meeting of Swift Board of Directors on the 22nd March 2024.

Subject to the approval of the conversion of Queen Elizabeth Sixth Form College to Academy status to join Inicio Academies, the first meeting of the Inicio Board of Directors would be held on the 15th April 2024 and a MAT (Multi Academy Trust) Development Day would be held on the 25th April 2024 at Queen Elizabeth Sixth Form College.

Early Careers Framework – Governor Tanya Singh submitted an update which advised the Compass Review was completed last term, with a view to review again in the Spring term. Consideration was being given by the Careers Adviser to the Wize Up Financial Education being rolled out.
