9. Head Teacher's Report

The Head Teacher provided a comprehensive update report to the Local Governing Body, a copy of which is held on file.

The Head Teacher advised that the school continued to work hard in bringing suspension numbers down, with a full explanation of the suspension figures provided in her report. Governor Lisa Morehead, who had undertaken a recent school Governor monitoring visit advised that the behaviour of pupils while she had been in school had been impeccable.

Governors noted the Alternative Provision provided as set out in the Head Teacher's report and questioned whether all providers had been visited by the school? The Head Teacher confirmed this was correct and all Alternative Providers have been visited by herself and the SENDCo, with all relevant Health & Safety checks are completed by the LA to ensure guidance and policies are adhered to.

The Head Teacher provided a comprehensive safeguarding update and advised that all child-on-child allegations were investigated thoroughly.

Governors noted that progress towards the Ofsted priorities continued and were now rag rated green across all areas within the Head Teacher's report.

Chief Financial Officer's Report

Governors noted the Chief Financial Officers report and the overview of the Management Accounts provision as of April 2024.

Operations and Business Manager Report

Governors noted the Operations and Business Manager's Report. A second round of Condition Data Surveys (CDC) was completed nationwide throughout 2023 and 2024. A Longfield site survey was completed in April 2024. Results of this survey would further enable items of prioritisation for Estates Management and the future planning of funding applications. A separate, independent survey was also completed in December 2023 as part of a due diligence process.

Trust ICT Managers Report

Governors noted the Trust IT Manager's report. A new phone system has been installed at Longfield, to replace the old system.

Governors **RESOLVED** that the Head Teacher's Report, Chief Financial Officer's report Operations and Business Manager's report be noted.

9. a.) School Improvement Partner Report

Governors carefully considered the Summer Term School Improvement Partner's visit report which had focused upon science, a copy of which is held on file. The Governors noted the positive main findings and actions to consider.

b.) The Longfield Academy Risk Register

Governors reviewed the current Longfield Academy Risk Register and requested that the level of risk regarding 'Category 1 – Strategic Risk' should be reduced in relation to Ofsted grading as the level of risk had been mitigated due to the work of the Academy. Governors requested that this be taken back to the Standards Committee to look at further in relation to the likelihood of occurring.

11. Special Interest Governors- Feedback

Behaviour and Attitudes – Governors noted that following on from her previous visits undertaken this Academic Year Governor Laura Snowdon suggested that it would be a good idea for her to obtain pupil's view next term.

Safeguarding – Governor Sarah Kelly had completed her visit and advised it was clear from observations, meetings and the evidence provided, that safeguarding was a priority for Longfield. Child Protection figures have reduced due to the positive work that has been completed alongside other agencies.

It was also noted that the Chair of Directors had also undertaken a visit during the Summer term to the School and discussed safeguarding with the Head Teacher

and DSL (Designated Safeguarding Lead) and had advised that managing safeguarding was dealt with well within the school.

Early Careers Framework – Governor Sarah Kelly had completed her visit and advised that all ECTs (Early Career Teachers) were making good progress.

Disadvantaged - Governor Lisa Morehead reported back following her visit that disadvantaged pupils were having their needs assessed and met and that the school was investing in their future and ensuring that they had opportunities to realise their own and the school's ambitions for them. It was noted that the systems and processes all link up with the child at the heart of them.

Looked After Children & Previously Looked After Children - Governor Lisa Morehead reported back following her visit that children were receiving a high standard of support and guidance from the school and that their needs are being assessed and met. Their experiences and what was being offered to them by teachers correlated with the schools' plan.

Quality of Education – The Chair advised that she had undertaken a learning walk around the school and could see the work undertaken by the School in this area.
